THAT DUPLICATE SERVICE MEDALS WORN BY MR HALIM ON ANZAC DAY WERE ORGANISED BY MYSELF AND THE RSL HEALESVILLE SUB-BRANCH MANAGER TO WEAR ON ANZAC DAY. I WAS RESPONSIBLE FOR IDENTIFYING WHAT I BELIEVED HE WAS ENTITLED. MR HALIM DID NOT SEEM TO HAVE MEDALS HE SHOULD HAVE ACCORDING TO SEVERAL PROFILES OF HIS MILITARY SERVICE. THESE PROFILES WERE HIS APPLICATION TO NOMINATE FOR HEALESVILLE RSL SUB-BRANCH COMMITTEE, NOMINATION FOR SUB-BRANCH PRESIDENT, LOCAL NEWSPAPER IN AN ATTEMPT FOR ELECTION TO THE SAME AS A COUNCILLOR AND HIS HOW TO VOTE CARD. THROUGHOUT THESE PROFILES THE TERM "INVOLVED" "SERVED" AND "DEPLOYED" ARE USED TO DESCRIBE MILITARY UNITS AND ORGANISATIONS WITH WHICH HE HAD SOME FORM OF ASSOCIATION.

IT WAS MY INTERPRETATION EACH TERM USED REFERRED TOO A PHYSICAL PRESENCE. FOR EXAMPLE, ON ONE DOCUMENT THE TERM "INVOLVED" REFERS TO THE GULF WAR WHEREAS IN ANOTHER DOCUMENT REFERRING TO THE GULF WAR THE TERM SERVED WAS USED AS IT WAS ALSO IN RELATION TO KOSOVO BOSNIA EAST TIMOR AND IRAQ. SIMILAR COMPARISONS CAN BE MADE IN RELATION TO OTHER LOCATIONS ETC. I BELIEVE IT WAS REASONABLE TO ASSUME ALL THREE TERMS MEANT THE SAME MEANING OR INFERENCE.

MR HALIM DID NOT SEEM TO UNDERSTAND WHAT SERVICE MEDALS HE WAS ENTITLED TO. IT WAS WITH GOOD INTENT I HAVE MISTAKENLY CHOSEN MEDALS HE IS NOT ENTITLED TOO. THE BRANCH MANAGER AND I DECIDED WE WOULD ORGANISE A DUPLICATE SET FOR ANZAC DAY WHICH WAS BARELY A WEEK AWAY AT THE TIME.

I RECALL IDENTIFYING FOUR MEDALS BUT NOT SIX AS HE WAS WEARING. I BELIEVE OTHERS WERE IDENTIFIED BY OR WITH THE SUB-BRANCH MANAGER OR MR HALIM AND THE MEDAL SUPPLIER.

I REGRET MR HALIM IS TO BE PUNISHED FOR PUTTING HIS TRUST IN ME.

AND I make this solemn declaration conscientiously believing the same to be true and by virtue of the provisions of an Act of the Parliament of Victoria rendering persons making a false declaration punishable for wilful and corrupt perjury.

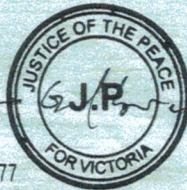
